6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 2075/11/17 (01-March, 2019)** at the Suddodhan Rural Municipality, **Rupandehi**. Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 2,65,000.00** which shall be valid for 30 days beyond the validity period of the bid.
